Dear Parents, Athletes, and Coaches:

My name is Brant Reyerson and I am the athletic trainer and physical therapist who provides athletic training services to Bondurant High School. I am contracted to cover all varsity football, all home JV football, wrestling invitational, home high school/middle school track and all home soccer events. This is my 5th year covering Bondurant sporting events and have really enjoyed being part of this community.

I provide free injury consultations once a week at the school and it is usually after school on Wednesdays where I will look at anyone that is hurt or having problems. If the injury is significant I will attempt to contact the parents to discuss the injury/situation.

We also offer free injury consultations to all parents, athletes and coaches where myself or another physical therapist will do a mini evaluation free of charge and give recommendations at our clinic. If something happens on a day when I am not there you can contact me in the office or on my cell phone and I will make arrangements to see them. I would really encourage you to take advantage of the free injury consultations vs. always going to the doctor. If I find something serious in my evaluation we can make arrangements for you to see your doctor or an orthopedic physician. I can usually get them into a specialist within 1-2 days.

Along with the free injury consultations we offer a Sports Injury Walk in Clinic in our downtown location. There is information available on Coach Busch's website.
