Dear Parents/Guardian:

The summer school program is planned to be a positive experience for everyone. The extension of the school curriculum into the summer months provides the time and school facilities to students who need and desire additional school work.

GENERAL INFORMATION:

Summer school will begin Monday, July 2 and end Friday, July 27, 2007. Enrollment in the Vernon Middle School Summer Program is open to Vernon residents referred by and registered through the school as well as non-residents.

RESIDENT FEE: \$110 per course

NON-RESIDENT FEE: \$210 per course

TIME SCHEDULE: Class times for subjects to be determined based on enrollment and need.

CLASS TIMES:

Period 1 – 8:00 to 9:00 a.m.

Period 2 – 9:05 to 10:05 a.m.

Period 3 – 10:10 to 11:10 a.m.

Period 4 – 11:15 a.m. to 12:15 p.m.

English

Math

Reading

Science

Social Studies

REGISTRATION: Dates for registration are June 18-22, 2007 at VCMS.

A registration form is attached to this notification. **ALL FEES ARE PAYABLE IN FULL AT THE TIME OF REGISTRATION BY EXACT AMOUNT OF CASH OR MONEY ORDER (MADE PAYABLE TO: VERNON CENTER MIDDLE SCHOOL). ABSOLUTELY NO PERSONAL CHECKS WILL BE ACCEPTED.**

THERE WILL BE A \$10 LATE FEE PER COURSE FOR REGISTRATIONS ACCEPTED AFTER THE JUNE 22nd DEADLINE.

OTHER INFORMATION:

1. Parents: If you are planning a vacation during summer school, it is recommended that you do not enroll your child due to the attendance requirement. Students are allowed two (2) excused absences. A combination of three (3) tardies or absences (excused or unexcused) will result in immediate dismissal from the program.
2. Any unexcused absence or tardiness may result in immediate dismissal.
3. Students must arrange their own transportation. Students should be dropped off in the morning at the main entrance of the school building. Parents are encouraged to be punctual when dropping off and picking up their children.
4. Each class will be one hour per day.
5. **NON-RESIDENT STUDENTS PLEASE NOTE: IT IS YOUR RESPONSIBILITY TO OBTAIN AUTHORIZATION FROM YOUR CURRENT SCHOOL TO RECEIVE CREDIT FOR COURSES TAKEN IN THE VERNON SUMMER SCHOOL PROGRAM.**
6. A minimum of seven students is necessary to guarantee the offering of a class.
7. Rules of deportment and school dress will not differ from those in force during the regular school year. Infraction of school rules could result in immediate dismissal.
8. All supplies such as pencils, paper, etc., must be furnished by the student. Textbooks will be supplied by the school; however, there may be a nominal fee for workbooks.
9. Parents will be advised of the pupil's progress halfway through the session and at the close of summer school.
10. Any infraction of school rules that results in a suspension from school will result in immediate dismissal from the summer school program.
11. Students expelled from summer school for behavior or attendance will forfeit tuition fees and will not be issued a refund. Student handbooks explaining rules are available in the VCMS office.
